### **Research context**

Legal protection measures for adults, such as guardianship and curatorship, currently affect more than 800,000 people in France. Their aim is to protect individuals with impaired mental or physical capacity, in particular by controlling their personal and property decisions. However, these measures raise crucial questions about respect for fundamental rights, particularly as regards autonomy, dignity and equality. These issues are particularly highlighted by legal instruments

international conventions, such as the United Nations Convention on the Rights of Persons with Disabilities (CRPD), which promotes a model of assistance based on respect for the will and preferences of individuals, as opposed to a purely substitutive model.

In France, recent reforms, such as the creation of the future protection mandate in 2007 or the abolition of prior authorisation for marriage for adults under guardianship or curatorship in 2019, aim to strengthen the rights of protected adults by introducing mechanisms that strike a balance between protection and autonomy. But many questions remain about their practical application and their real impact on the lives of the individuals concerned. Furthermore, while the ageing of the population and the lack of effectiveness of the rights of vulnerable adults have led the public authorities to consider reforming the system as a whole, and several reports have been published on the subject, no major changes have yet been adopted or even submitted to Parliament. Internationally, alternative models, such as the assisted decision-making practised in certain Nordic countries, are encouraging us to rethink the current arrangements.

This thesis project is at the crossroads of these national and international issues. The research is mainly incremental, in that it explores existing questions about the rights of protected adults. However, it also aims to be innovative by proposing an interdisciplinary and comparative approach, integrating law, sociology and ethics.

### **Research objectives**

The main objective of this thesis is to analyse the tensions between the legal protection of adults and the preservation of their fundamental rights, in order to propose solutions to better reconcile these two requirements. This problem is broken down into several specific objectives:

- **In-depth legal analysis**: study national (Civil Code, case law) and international (CRPD, European Convention on Human Rights) standards to understand how they define and frame the rights of protected adults.
- Study of implementation: Evaluate the practical application of protection measures by judges, by people in charge of protection measures and by reception structures in the event of accommodation (EHPAD, specialised reception homes - MAS, hospitals, etc.), by identifying the obstacles encountered with regard to respect for fundamental rights.
- International comparison: Explore best practice other countries, particularly in the area of decision support, to learn lessons that can be applied to the French context.
- **Concrete proposals**: Draw up recommendations to improve French systems, both in legislative and practical terms, taking into account changes in society and international commitments.

### **Positioning**

This project is anchored in a national and international positioning. At national level, it aims to shed light on the reforms needed to better protect the fundamental rights of adults while respecting their autonomy. Internationally, it contributes to the debate on changes in models of protection and assistance for vulnerable people, by interacting with work carried out in other legal systems.

**Detailed project** (scientific details on the subject, questions or issues addressed, programme and planned timetable) and prospects for the team/laboratory (3 pages maximum) :

Scientific details on the subject

The subject of this thesis is the tension between legal protection and respect for the fundamental rights of protected adults. Measures such as guardianship and curatorship, while essential for protecting vulnerable individuals, raise profound ethical and legal issues. By restricting the exercise of certain fundamental freedoms such as marriage, the right to make decisions about one's health and the management of one's assets, these measures can sometimes compromise the dignity and equality of protected adults. From a scientific point of view, this thesis explores a key question: how can legal protection and recognition of the autonomy of protected adults be reconciled while respecting fundamental rights?

Ways of reconciling autonomy and protection will need to be explored, prioritised and perhaps extended; here we are thinking in particular of anticipatory measures such as the future protection mandate, the improvement of which is being called for by notaries. Where there is a discrepancy between respect for autonomy and the need for protection, as evidenced in particular by a conflict between the persons wishes and his or her interests (as determined by a third party), it will be necessary to determine in which situations preference should be given to one or the other. The question is how to ensure that protection does not lead to an excessive form of diminution and that a paternalistic approach does not lead to the sacrifice of equality beyond what is strictly necessary. The challenge is to strike a balance between the obligations of protection, particularly under French law (Civil Code), and the international principles enshrined in instruments such as the United Nations Convention on the Rights of Persons with Disabilities (CRPD). This subject is part of an interdisciplinary field, involving law (public and private), the sociology of disability and the ethics of vulnerability.

### **Questions and issues addressed**

This project aims answer a number of scientific questions:

1. What are the national and international legal frameworks governing the fundamental rights of protected adults?

- Analysis of key legal provisions and case law.
- Identification of tensions between national law and international commitments (e.g. CRPD).
- 2. How are legal protection measures applied in practice, and what impact do they have on the rights of the people concerned?
  - Study of social, judicial and administrative practices.
  - Assessing the perceptions and experiences of protected adults.

# 3. What alternative models can be considered to strengthen the autonomy of protected adults?

• Comparative analysis with other legal systems (particularly countries that have adopted decision support models).

### Scientific challenges :

- Legal complexity: Reconciling the need for protection with the principles autonomy. Determining the weight to be given to the wishes (past or present) of the protected person. Reflection on the interests of the protected person and the appropriate procedures for defining them. Seeking out and recognising manifestations of residual autonomy.
- Lack of empirical data: Insufficient qualitative research into the practical impact of protection measures.
- Ethical dimension: Tensions between the desire to protect and respect human dignity.

### **Programme and timetable**

The thesis will be structured around three main stages, spread over three years:

- Year 1: legal research and theoretical analysis
- Year 2: finalisation of legal research and start of final drafting

• Year 3: continuation and completion of final drafting

### **Outlook for the laboratory**

This thesis will strengthen the laboratory's research areas, in particular those relating to human rights, vulnerability and changes in contemporary legal frameworks. Expected outcomes include:

- Scientific output: Articles published in specialist journals (law, sociology of disability).
- **Practical impact**: Proposals for improving French systems, useful for public decision-makers and those working in the field.
- **Interdisciplinary enhancement**: Enrichment of interdisciplinary approaches, particularly in ethics and sociology, within the laboratory.

Actions planned as part of the dissemination Scientific, Technical and Industrial Culture (STIC) in addition to the Fêtes de la Science actions (1 page maximum) :

- Involvement with organisations, particularly associations, that take charge of protected adults, in order to offer training or assistance in developing tools such as ethical charters.
- Participation in the Masters forum: the aim will be to present the work of research in general, and theses in particular, to undergraduate students.
- Participation in meetings organised between current and former Master's students discuss embarking on a doctorate and the approach to adopt (construction of the subject, etc.).

A reasoned opinion from the thesis supervisor on the proposed research, with regard to the scientific and technological objectives pursued and their place in the research orientations of the host laboratory:

The aim of the research is to measure the difficulties involved in reconciling the protection of people whose faculties are impaired with respect for their fundamental rights. As well as assessing extent of the difficulties, the research will also aim to propose solutions to achieve a balance. The aim is to succeed in supporting vulnerable people without diminishing them in any way. These issues are linked to questions of paternalism, autonomy and equality. They permeate, with varying degrees of acuity, all areas in which certain vulnerabilities need to be taken into account. It is at the crossroads of personal and family law and fundamental rights, while also including important aspects of medical law. It therefore fits in perfectly with CUREJ's research guidelines, which focus on these areas and on the balance at issue here in relation to vulnerability, particularly in the 'person(s)' theme.
